IMPORTANT

Candidates are required to go through this document and the **advertisement** carefully and acquaint themselves:

- 2. Candidates can fill the application form in "Online" mode only.
- 3. Online submission of Application Form may be made by accessing the link '<u>SCIENTIST</u> RECRUITMENT-01/2025' available on CGCRI website https://www.cgcri.res.in
- 4. Candidates must follow the instructions strictly as given in this document and the advertisement. Candidates not complying with the instructions shall be summarily disqualified.
- 5. Candidates must retain the following documents with them as reference for future correspondence.
 - i) A copy of mail confirming registration
 - ii) Proof of fee paid i.e. Payment Receipt
 - iii) A copy of the Application Form generated after completing online application.
 - iv) A copy of certificates & testimonials uploaded with the online application.
- 6. (a) Candidate must ensure that mobile number and email address filled in the online application form are his/her own as CGCRI will make communications by SMS or email on given mobile number and email ID only.
 - (b) The candidate himself/herself shall be held responsible for non-receipt of latest information due to wrong mobile number or mailing address filled in the online Application Form.
 - (c.) The fee can be remitted in the following ways:

 - iii) Other Payment Modes like UPI etc.

Important Notes:

- 1. Candidates can apply for more than one post but a separate online registration/fee payment/form submission has to be done for each post.
- 2. Only one application per post can be submitted by a candidate.
- 3. One email-ID is valid for only one application against any of the given posts. However, the same mail ID can be used for applying against different post code.
- 4. Information regarding status of online application will be available on the "Candidate Home Page" after the candidate logs in with his user-id and password. Candidates can check the status of online Application on the website and take the suggested action.
- 5. Candidates will not be allowed to change any information given in the Online Form after it has finally been submitted online.

Section-I: MODE OF SUBMISSION OF APPLICATION FORM AND FEE DETAILS

A candidates can fill the Application Form in "Online" mode only by following the link <u>'SCIENTIST</u>

RECRUITMENT 01/2025' available on CGCRI website https://www.cgcri.res.in

Before submission of application form, make the following preparations:

- 1. Read the full advertisement (No. 01/2025), available on the website carefully.
- 2. Decide the post to be applied as per eligibility. Detail of the advertised posts and their eligibility is given in the "Advertisement" document, available on the website.
- Candidate should have scanned image of his/her latest photograph documents, in PDF format
 (Proof of Date of Birth, Education, Experience etc.) for uploading as part of submission of online
 application.
- 4. Decide on the mode of payment of fee i.e. through NET Banking/Credit Card/Debit card or UPI etc. through the following link:

- 5. The information desired to be filled in the online application may also be kept ready.

The application process is to be completed in the following three distinct stages and strictly within the last date as mentioned below.

STAGES OF APPLICATION:

- 1. ONLINE REGISTRATION
- ONLINE FEE SUBMISSION
 (Only for candidates not exempted from fee payment)
- 3. ONLINE APPLICATION FORM SUBMISSION

IMPORTANT:

Candidates are advised not to wait till the last date to have sufficient time in completing the form submission well in time. This shall also enable them to repeat the steps, within the last date, in case their fee payment is declined by the bank.

In case, a candidate is not able to pay the fee or faces any technical difficulty to fill the online application form then he/she must write immediately to helpdesk informing the same.

NOTE:

- The application fee is Rs. 500/-. Please refer the advertisement to know the categories of candidates exempted from fee payment.
- In addition to the application fee, service/processing charges will also be paid by the candidate for online payment of fee through NET Banking/Debit Card/Credit Card/UPI etc., along with the Service Tax, as applicable by the bank.
- 3. The candidate must note that after submission of the application form it cannot be withdrawn.

 Claims for refund of application fee will not be entertained.

Section-II: METHOD OF SUBMISSION OF APPLICATION FORM

- 1. Access the link <u>'SCIENTIST RECRUITMENT 01/2025'</u> available on CGCRI website https://www.cgcri.res.in
- Download the 'Advertisement' and 'How-to-apply online' documents, available on the website, and read it carefully to understand eligibility criteria and other requirements for submission of application online.
- 3. The steps to be followed are:
 - (a) Fill in the registration form by accessing the link 'Step-1: Registration' available on 'Home' page. The entries made at the registration stage shall reflect in the application form and cannot be edited later. Note down the registration number displayed on submission of the registration form.
 - (b) Access your registered email ID to access the mail sent by registration process and click the link given therein for activation of your account. Your Login-ID, same as the registration no., and the Password, as entered during registration, shall be required to be completed the remaining phases of application submission process.
 - In case you do not receive any email after registration then please write to us at r_and_c.cgcri@csir.res.in mentioning your registration number.
 - (c) The candidates who do not belong to fee-exempted category can access the 'Step-2: Fee

 Payment' link available on the 'Home' page and follow the steps of fee submission as given in

 'Fee Payment Procedure' document, available on the website.
 - (d) The candidates belonging to fee-exempted category can directly go for application form submission.

- (e) Access the 'Step-3
- (f) <u>Application Form'</u> link available on the 'Home' page which leads to candidate login webpage. Login using the login-ID (registration no.) and password as set during registration and fill the online application form as per instruction given on the website and also this document.
- (g) The online application form has four sections which need to be filled by candidates. These sections are:
 - 1) Personal Details
 - 2) Qualification Details
 - 3) Experience/Research (incl. Publication/Patents details)
 - 4) Other details
- (h) The contents of the individual sections get automatically saved when the user navigates to the next section using "Save and Next" button.
- (i) In case the candidate logs out or his/her session terminates before final submission then the saved entries shall be made available when he/she logs in again.
- (j) A preview of the complete application form (comprising of entries of all the four sections and registration details) is displayed when the user chooses "Preview and Submit" button available in the last section i.e. "Other details". Candidates must review the content of their application thoroughly.
- (k) There are two buttons "EDIT" and "Final Submit and Take Print" provided on the "Preview of application form" page. User must exercise due caution and should click "Final Submit and Take Print" only if all the entries of all the four sections are finalized and no more modifications are required. If the user wants to make changes to any of the entries (except registration details) then he/she should choose "EDIT" button.
- (l) A copy of the submitted application (PDF format) shall also be sent on the registered email ID of the candidate.
- (m) Candidates can also take a copy of the submitted application by accessing the link 'Print Application Form' given on their 'Candidate Home Page' webpage available after login.

- (n) Candidates who are employees of Government departments have to get their application forwarded through proper channel for which they must refer the relevant instructions given in the advertisement.
- (o) The application forms of partially completed steps shall be cancelled. No refunds shall be made for such incomplete applications.

INSTRUCTIONS FOR PHOTOGRAPH TO BE UPLOADED ONLINE:

Photograph: Candidates are advised to take passport size coloured photograph with white background. Passport size photographs are to be used for uploading in online Application. The photograph must be taken on or after 01.10.2025. Photograph should not have cap or goggles. Spectacles are allowed if being used regularly. The size of the photograph should be 4.5 Cmx3.5 Cm and the scanned file should be of type JPG/JPEG only between a file-size of 10 KB and 50 KB.

NOTE:

- i) Request for change in any particulars in the online Application shall not be entertained under any circumstances.
- ii) Incomplete Applications shall be rejected.
- iii) Status of online application shall be displayed on the "CANDIDATE HOME PAGE" after the candidate logs in using his login-ID (registration no.) and password.
